thanks to premium subsidies web oct 15 2022 obamacare is the patient protection and affordable care act aca most people think it only affects health insurance but it has changed the way the u s delivers health care overall the term obamacare was first coined by critics of the former president s efforts to reform health care but the name stuck web aug 7 2014 obamacare improves the quality of coverage for example all major health plans must now offer 10 essential benefits including maternity care lab services and mental health services obamacare s cost assistance lowers premiums and or out of pocket costs many single adults and families qualify for marketplace cost assistance or free or low cost coverage under medicaid chip based on factors like family size and income web aug 8 2014 obamacare the aca gives american employers with over 50 full time equivalent employees the choice between providing insurance that meets the standards of obamacare or paying the penalty this penalty helps to offset the cost of employees who aren t covered through their employer to purchase insurance through the public health insurance exchanges instead of using emergency services web jun 5 2018 obamacare is the nickname for the affordable care act signed into law by then president barack obama in 2010 the aca was his signature legislation web obamacare affordable care act health insurance reform healthcare reform enacted by the 111th united states congress effective march 23 2010 12 years ago most major provisions phased in by january 2014 remaining provisions phased in by 2020 penalty enforcing individual mandate set at 0 starting 2019 citations public law 111 148 web jan 26 2023 obamacare a record 16 3 million americans signed up for health insurance plans through the affordable care act s marketplaces beating last year s record by 13 percent web the law has 2 parts the patient protection and affordable care act and the health care and education
